

## **The Ron Cameron Foundation Privacy Policy**

This Privacy Policy discloses the privacy practices for [www.RonCameronFoundation.org](http://www.RonCameronFoundation.org) and applies solely to information collected by this site. It will notify you of the following:

1. What personally identifiable information is collected from you through the site, how it is used and with whom it may be shared and why.
2. What choices are available to you regarding the use of your data.
3. The security procedures in place to protect the misuse of your information.
4. How links to other sites interact with this site and how your privacy is affected.
5. How you can correct any inaccuracies or update information you provide.

At RonCameronFoundation.org your privacy and security are our top priority.

### **Information Collection, Use, and Sharing**

The only information we obtain about is that which we require to process billing and credit card charges for registration, sponsorship and/or donations as well as to communicate with you about future events. You may opt out of communications at any time.

The information collected is never shared, revealed, sold, rented or made public for any reason to anyone except to provide credit card information to our credit card processing partners or if required to do so by law, court order, or to protect the safety of others (details are below). Company and/or Personal identity information provided (name, company, address, phone numbers, email, etc.) is never disclosed to any individual or entity.

We are the sole owners of the information collected on this site. Only we have access to/collect information that you voluntarily give us via at our site or by means of direct contact from you. We will use your information to respond to you, regarding any reason you contacted us or to serve you as requested.

Only select foundation volunteers who need the information to perform a specific task (for example, billing or customer service) are granted access to personally identifiable information. The equipment in which we store personally identifiable information is kept in a secure environment and is password protected with limited access. All information is also backed and stored in a remote location on a digitally encrypted server.

### **Certain Disclosures**

We may disclose your information if required to do so by law, court order, or subpoena or if we believe that such action is necessary to protect the rights, property, and/or safety of others.

### **Cookies**

Each time a member logs onto this site, we store a temporary 'cookie' in the browser files of that member's computer. This cookie is used during your online session to allow you free access to the Secured Member's Area, without repeatedly requiring you to re-enter your user name and password. When you log off or leave the site, the Cookie is automatically removed from your computer. We DO NOT use cookies to track visitor history, but it does allow us to track the materials you visit on our site and keep track of who downloads what from our site for security purposes. We have no interest in what is on your computer or what other sites you visit when surfing the internet.

### **Registration, Sponsorship, or Donation Information**

When you register, sponsor or donate with RonCameronFoundation.org you will be required provide us with detailed information about yourself for billing and security purposes. This detailed data collection includes such personally identifiable information as name, address, phone number, email address, and credit card information.

### **Personal and/or Email Information in Messages or Content**

Please be aware that any personal information you include in your email messages to us can and may be accessible for viewing and data collection by others on the site. We are not responsible for any information you include in such electronic transmissions.

### **Site Security Secured Information Transmissions**

The safeguarding and security of your personal information is important to us. We use several security systems including Secure Socket Layer 128 bit technology data encryption (SSL) and authentication to protect the loss, misuse and alteration of your personal information under our control.

We follow generally accepted Internet purchase protocol and practices to safeguard and secure all site visitor data submitted to The Ron Cameron Foundation during transmission and after procurement. Due to the vast amount of cyber-threats, no method of information transmission over the Internet or type electronic storage is perfectly secure. As such, even though we make every attempt to secure data, we make no express or implied warranties or guarantees that its 100% secure.

Due to the very public nature of email and the ease with which it can be forwarded to countless users, it is relatively insecure. DO NOT send private information to us by email.

### **Linking To Other Web Sites**

In order to provide visitors with greater value, some of our pages may provide links to various third parties to for more in depth support or product information, including but not limited to client, affiliate and partner sites. Your personal information or the cookie placed by our site are never transmitted to any site you which you link to from our site. However, keep in mind that many sites do attempt to capture visitor information when you browse those sites and many sites Phish. We are not responsible for the practices employed by sites linked to or from our site nor the information or content contained on those sites. Our privacy policy is not in effect when you link to another site from our site. Once you leave our site, we are not able to alert you should another site attempt to gather information from your browser.
